Dear Chairwoman Lincoln,

We understand and appreciate the critical need to provide additional funding for the child nutrition school meal programs. However, we are deeply disappointed in your proposal to cut the Environmental Quality Incentives Program by \$2.8 billion over the next decade in order to provide this funding. There are other sources for this funding outside of the Farm Bill conservation programs that could be tapped to pay for these needs without taking away from the programs that support farmers and forest landowners in their efforts to provide conservation benefits in addition to food, forest products, and fiber. However, if Farm Bill resources are determined to be the only resort, then fairness demands that the conservation title should not bear the full burden of providing the solution.

This current proposal would not only rob farmers, ranchers, and forest landowners of conservation and environmental stewardship assistance in the next decade, but would take away well over \$2 billion from the farm bill conservation baseline, or nearly half of the widely-lauded conservation increase in the 2008 Farm Bill. This cut clearly violates the carefully negotiated compromise that you supported in the 2008 Farm Bill.

Farmers, ranchers, and forest landowners are eager to share the cost of protecting the environment, but demand for participation in conservation programs routinely far outstrips available funding. This proposal will only exacerbate that problem, and will undermine conservation practice adoption on-the-ground.

Applied conservation provides clean water, energy conservation, erosion reduction, carbon sinks, improved wildlife habitat, wetland protection, and other important public benefits that should not be lost. We urge you to modify the current proposal to craft a fairer offset package to provide the funding needed for child nutrition reauthorization. We would like to work with you and the committee to find an equitable solution to this pressing problem and help provide added resources to school feeding programs.
