Accomplishments

Major goals of the project

The long-term goal of the Legal Aid of Nebraska BFRD Project is to increase the number and enhance the sustainability of farm and ranch enterprises in Nebraska and South Dakota by providing land, skills, and education to beginning farmers and ranchers; estate and transition planning to retiring landowners; and by matching beginning producers who need land with retiring landowners who need a successor. The project will address the following Priority Topics for Standard Grants: Business management and decision support strategies that enhance the financial viability of beginning farmers and ranchers, marketing strategies that enhance the competitiveness of beginning farmers and ranchers, legal strategies that assist beginning farmers with farm or land acquisition and transfer. Program objectives: 1. Provide to beginning farmers and ranchers and ranchers and retiring landowners individual consultation for legal matters that include contracts, structure of enterprise, use of

What was accomplished under these goals?

IMPACT: "I am a farmer's daughter who is wanting the next generation to continue farming." We learned "how we can best help our son with decisions on coming back to the farm by encouraging an enterprise." The workshop gave us idea "especially for non-successor scenarios." "They gave me a number of options that I can and will consider for estate planning." "I appreciate the availability of this service to farm families of Nebraska. Thank you. Invaluable." These comments, among many others, demonstrate the need met by Legal Aid of Nebraska's Beginning Farmer and Rancher Development Program in Nebraska and South Dakota's agricultural families and communities.

Legal Aid of Nebraska and its partners have been on the forefront of increasing the number of beginning farmers and ranchers in Nebraska through its efforts under this grant. Our Program has served over 2,000 farmers and ranchers in Nebraska, South Dakota, Colorado, Iowa, and Missouri. We've assisted over 300 Program participants in starting to farm, as well as increased the number of farmers and ranchers accessing state and federal farming programs. The 2012 Census of Agriculture indicates the beginning farmer numbers are on the rise in Nebraska and holding steady in South Dakota. Furthermore, farmers under the age of 34 increased in South Dakota and the average age of Nebraska farmers (55.4) is one of the lowest in the nation.

WORKSHOPS: Legal Aid and its partners held 51 workshops with 2,133 participants during the grant period. Workshops were held in Nebraska (43), South Dakota (3), Iowa (3), Colorado (1), and Missouri (1). Workshops topics focus upon legal matters relevant to beginning farmers and ranchers and transitioning landowners, including contracts/leases, structure of enterprise, use of entities, estate and succession planning, options and installment contracts, federal and state programs and services, and family communication. Workshop topics and information is continually evolving to meet the needs and wants of participants and statutory and case law updates. CLINICS: Legal Aid held 116 clinics with 971 participants during the grant period. Clinics were held throughout Nebraska (114), South Dakota (1) and Colorado (1). Clinic consultations cover a wide variety of topics, both legal and financial, and are intended to build upon information provided in workshops. Clinic participants complete written evaluations, which indicate the following:

ONE-ON-ONE MENTORING: Mentoring is ongoing, with 23 clients. The one-on-one sessions are aimed to providing athome sessions to individuals requesting extended assistance with legal questions and, if appropriate, drafting legal documents.

For example, one-on-one mentoring assisted two beginning farmer families with establishing an LLC and drafting land, livestock, and machinery leases. We also assisted with applying for the Nebraska Beginning Farmer Tax Credit and Personal Property Tax Exemption. The two families now lease, and eventually own, an approximately 400-head grass-fed cattle herd in northeast Nebraska.

We have also assisted multiple families with educating about legal options for succession planning. For example, a father and beginning farmer daughter in Lancaster County, Nebraska decided to employ Nebraska's transfer on death deed after a oneon-one session. Similarly, a father in southeast Nebraska with eleven children and one on-farm successor had multiple inperson and telephone sessions to discuss succession planning, family communication, and tax strategies. The father now has a plan to bring his on-farm heir into the operation while also providing opportunities for his other children to inherit.

NEBRASKA NETWORK FOR BEGINNING FARMERS: We lead the Nebraska Network of Beginning Farmers, which is comprised of stakeholders in Nebraska agriculture, specifically those beginning farmer stakeholders. Participants include the University of Nebraska-Lincoln, Nebraska College of Technical Agriculture (NCTA), Nebraska Department of Agriculture, Nebraska Investment Finance Authority, Farm Credit Services of America, Nebraska Cattlemen, The Nature Conservancy (TNC), Center for Rural Affairs, Nebraska FSA, and Nebraska NRCS. The Network meets quarterly to discuss issues pertaining to beginning farmers in Nebraska.

Network meetings provided the impetus for a recent expansion of NCTA's 100 Cow Program; NCTA and TNC entered into an agreement to allow NCTA's student cattle herd to use TNC lands in west-central Nebraska for summer grazing. TNC requires heavy grazing to assist with the conservation of blowout penstemon as well as generally maintaining the grasslands in good health. This agreement allows NCTA students hands-on learning about a range of topics, from transporting the herd, horsemanship skills, grazing cattle, and conservation planning.

BLOG/WEBSITE: Our website is growing. The blog received 12,660 views, with approximately 10,000 of those views from the U.S. We posted 184 blog posts and 20 articles, covering topics such as farm bill programs, state and federal beginning farmer programs and resources, financing, grant opportunities, estate and succession planning, local food/cottage food laws, marketing, leases, crop insurance, disaster preparation and designations, use of entities, tax concerns, inheritance, family communication, and emerging legislation and regulations.

NEBRASKA BEGINNING FAMRER TAX CREDIT: Our program disseminates information and assist with applications for the Nebraska Beginning Farmer Tax Credit. The 2013 - 2014 annual report from the Nebraska Beginning Farmer Board shows submitted applications increased almost 50% from 2012 to 2013 and the total monetary value of the tax credit increased by 8%. Moreover, we assisted 17 beginning farmers in grant year 3 with preparing leases for the Program and anticipate those beginning farmers will submit applications prior to December 31, 2015.

What opportunities for training and professional development has the project provided?

This project has provided formal continuing legal education instruction and individual learning and development. Angle Miller attended multiple CLE presentations on estate and business planning, farm succession planning, and ethics. Ms. Miller has also engaged in individual learning and development on state and federal estate planning, state and federal tax policy for beginng and transitioning farmers and ranchers, contracts, leases, and general agricultural law and policy. Additionally, the members of the Nebraska Network for Beginning Farmers, through the quarterly Network meetings, have learned and developed skills in federal and state policies and programs (especially regarding the 2014 Farm Bill), sustainable farming methods, urban agricultural/local food production, and conservation policies and practices.

How have the results been disseminated to communities of interest?

Workshops and clinics are advertised via newspaper, newsletters, listservs/email, the websites of Legal Aid of Nebraska, Nebraska Department of Agriculture, Center for Rural Affairs, and Dakota Rural Action, conferences/shows such as Husker Harvest Days, and through our Nebraska Network of Beginning Farmers partners. Word-of-mouth from previous participants and participants who wish for a "refresher" also discuss the topics with the community at large.
